Pierre MARIANI
Head of International Retail and Financial Services,
Member of the Executive Committee

Pierre Mariani holds a MBA from the Ecole des Hautes Etudes Commerciales (HEC business school), graduated in Law from Paris University and is an alumni from the National School of Public Administration (ENA).

He joined the Ministry of Finance, as a Senior Treasury official (1982-1986) and then, the Budget Department of the Ministry as Head of the Transports Sector (1986-1988), head of Budgetary and Fiscal policy (1988-1992), and Deputy Director in charge of the Department of Employment, Health and Social Security (1993).
