Explanatory note

The cash flow statement for the year ended December 31, 2016 has been prepared on the basis of the audited financial statements for the financial years ended December 31, 2016 and December 31, 2015. These financial statements were prepared in accordance with accounting principals applicable in France.

The cash flow statement has been prepared using the indirect method.

Investing activities are the acquisition and disposal of long-term assets and other investments not included in cash equivalents.

Financing activities are activities that result in changes in the size and composition of the contributed equity and borrowings of the entity. Operating activities are the principal revenue-producing activities of the entity and other activities that are not investing or financing activities.
